  - e.g. "I nominate myself for election to the committee. I am not required to seek leave to be appointed to a management committee under s39 and s40 of the Act."
  - Your seconder must also direct message the Secretary on Slack, e.g. "I second the nomination of [MEMBER NAME] for election to the committee".

Nominations must be received at least 7 days before the annual general meeting, i.e. by <mark>1 pm on </mark> Saturday 9<sup>th</sup> September 2023.

The secretary will acknowledge your nomination by email.

### Relevant rules

Refer to constitution rule 33, Nomination of committee members.

#### 33 Nomination of committee members

33.1. At least 21 days before an annual general meeting, the secretary must send written notice to all the members —

33.1.a. calling for nominations for election to the committee; and

*33.1.b. stating the date by which nominations must be received by the secretary to comply with subrule 33.2 and 33.3.* 

*33.2.* A member who wishes to be considered for election to the committee at the annual general meeting must nominate for election by notifying the secretary at least 7 days before the annual general meeting.

*33.3. Each nomination must be supported by a second member. The second member must notify the secretary of their support for the nomination at least 7 days before the annual general meeting.* 

33.4. Notices to the secretary for the purposes of rules 33.2 and 33.3 must be either -

33.4.a. A written notice; or

33.4.b. A direct message.

33.5. (deleted.)

33.6. A member whose nomination does not comply with this rule is not eligible for election to the committee unless the member is nominated under rule 34.2.b.

# **Eligibility requirements**

#### Refer to: Eligibility requirements for committee members: Associations info

Under s39 of the *Associations Incorporation Act 2015* (WA), a person is prohibited from sitting on the management committee of an incorporated association (without prior approval from the Commissioner for Consumer Protection) where they:

- are an undischarged bankrupt or their affairs are being managed under insolvency laws;
- have been convicted of an offence in connection with the promotion, formation or management of a body corporate;
- have been convicted of an offence involving fraud or dishonesty punishable on conviction by three months or more imprisonment; and/or
- have been convicted of an offence under Part 4, Division 3 (the duties of officers provisions) or section 127 (the duty with respect to incurring of debt) of the Act.

A person is disqualified from sitting on a management committee for the period of time specified in s40 of the Act.

A person who is disqualified must not accept an appointment or act as a member of the management committee without seeking prior approval from the Commissioner for Consumer Protection.

A person who is disqualified and wishes to sit on a management committee must request permission by submitting Form 12 - Application for leave to be appointed to the committee to the Commissioner.

It is the responsibility of each individual to ensure they are eligible to act as a member of the Management Committee.
